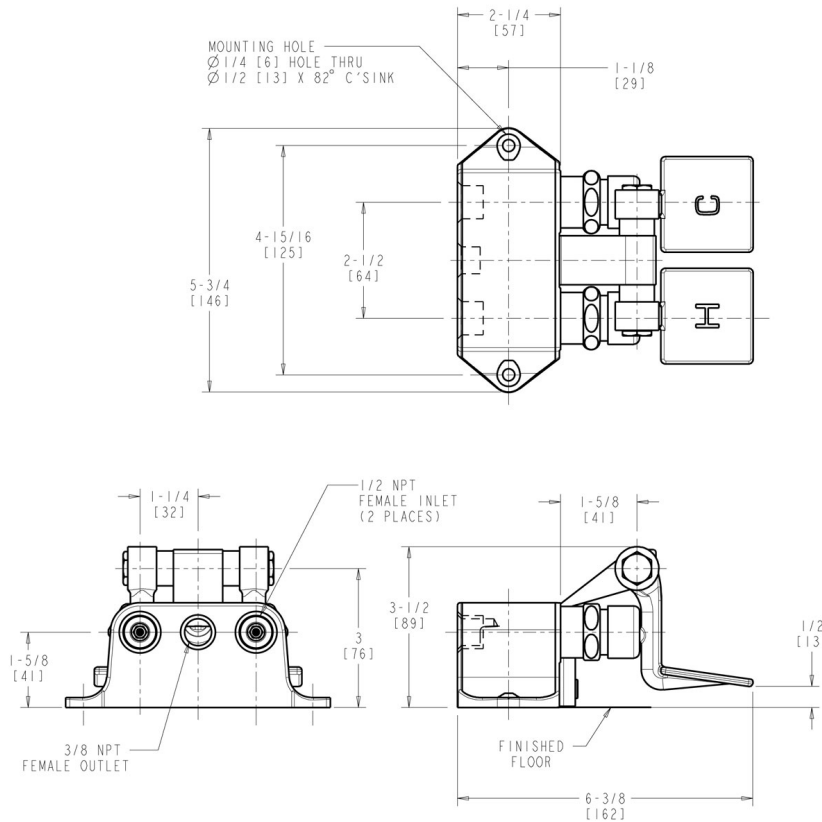

NAIAD rebuildable auto-timed metering cartridge, adjustable run time from 2 to 15 seconds, opens with push, 0.20 max gallon/cycle. Two 1/2" NPT female thread inlets. 3/8" NPT female thread outlet. ECAST® construction with less than 0.25% lead content by weighted average. This product is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9 by CSA, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



Operation and Maintenance
