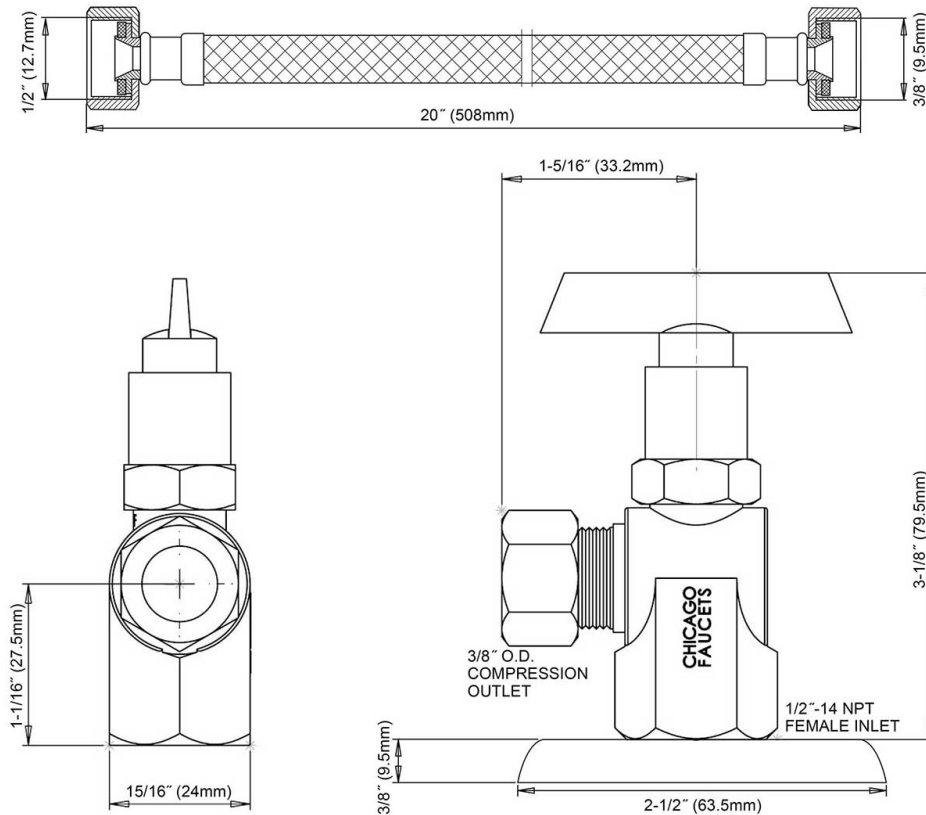

Chicago Faucets No. STB-21-13-PR-AB, Angle Stop Fittings (one pair) with ball valve, supply hose, and loose key handle. Chrome plated. 1/2" NPT female thread inlet and 3/8" O.D. female compression outlet. Slip wall flange. Flexible, stainless steel hose with 3/8" x 1/2" female compression fittings. ECAST® construction with less than 0.25% lead content by weighted average. This product is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9 by CSA, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



Operation and Maintenance

After installation, remove spout outlet or flow control and flush faucet thoroughly to clear any debris. Care should be taken when cleaning the product.
